Dear Sir or Madam,

The above named individual claims that he served two tours in Vietnam and was awarded multiple valor medals. He claims his OMPF, obtained via NARA, which does not evidence service in Vietnam, belongs to another veteran of the same name.

A DD 214 supplied by John Doe supports his claim to combat and valor. However it appears suspect.

The active duty dates on his OMPF DD 214 are 9 Jan 78 to 29 October 83. There is no reference to Vietnam service or valor medals. A previously obtained FOIA document shows active service dates of 9 Jan 71 to 29 Oct 83. There is no reference to Vietnam service or valor medals. What is the explanation for the conflicting service dates?

Please send all releasable information from the OMPF of Johnny Doe and any other documents, to definitively confirm that either he served or did not serve in Vietnam as an infantry rifleman in 1969, and as an infantry medic, in 1971, as he claims.
