Dear Ms. Louis,

Thank you for your email of 3 March 2016 regarding registering DD 214s at the courthouse. If possible, I would like to know if **Mr. Johnny Lee Doe**, an Army veteran born in 1952, registered his DD 214 at your location or at another court in Queens. **Mr. Doe** gave me the attached (partially redacted) DD 214, which he claims is proof of his two tours in Vietnam and multiple valor medals. He states that he registered this document at a county clerks office in Queens.

With **Mr. Doe's** permission I reviewed his official military personnel file (OMPF), obtained from the National Personnel Records Center, in Saint Louis (attached/partially redacted). While **Mr. Doe** served honorably in the Army and the National Guard, there is no record that he served in Vietnam.

If possible, I would like to know if **Mr. Doe** registered a copy of the attached DD 214, labeled Document 1, at your office, or at another county office in Queens.
