On or about 10 June 1952, W Sgt Kilpatrick assigned me to a job on moving scrap metal. CWO Hart took me aside after I had finished the job and asked me if I could walk faster. I told him I was walking the way I had always walked all my life. He said, "You don't deserve to be a corporal." I answered, "Well, bust me if I don't deserve to be a corporal." CWO Hart said he didn't like my attitude and took me over to see Captain Chambers. On the way over, CWO Hart asked me some personal questions and I told him that under the 31st Article of War, I didn't have to answer anything that might incriminate me.

After we reached Capt Chambers and he had heard the story from CWO Hart, he asked me if I had been walking at my normal gait. I answered, "Yes, sir." Mr. Hart then asked me, "Have I ever given you any reason to think that I am prejudiced against you?" I answered, "Yes, sir, a week ago when there was a sign being painted in the shop, I asked A/3c Carlisle where he was going to hang the sign. You said, 'If guys keep asking about this sign, we'll hang it around somebody's neck, and I think you meant me...but I don't think that anyone around here could hang any sign around my neck if I didn't want them to.' Captain Chambers said to me, "The trouble with you Bulger is you have a crucifixion complex." Captain Chambers then told me, "We are going to draw up paper work on you now, and if you don't change your ways, we'll take legal action against you." Captain Chambers went on to talk about a discharge and it looked to me as if he were threatening me with a bad discharge. He told me without a good discharge, I

would never get a job on the outside. To show him I was not intimidated by his threats when I had done nothing wrong, I said, "I could go back to the work I used to do no matter what kind of a discharge I had received." I was sent back to work. So I went back to work, thought over what had happened and in my opinion Mr. Hart and Captain Chambers seemed prejudiced against me. I figured if they wanted me busted they would find some kind of an angle. Rather than have a bad mark in my record, it would be better to get a voluntary bust, I felt, so I went up to the 1st Sgt, requested a voluntary bust, but was told it was impossible.

About three days later, all the men had left the shop for the daily 15-minute coffee break. I was sitting alone in the shop, not having gone with the men because I don't smoke nor drink coffee so do not go out of the shop for the break. Sitting alone, I had rested my elbow on my knee and my head on my hand, and I was daydreaming till the men came back and we could get started at work. Mr. Hart stepped in a side door about three steps away from my chair and tapped me on the shoulder and asked me what was I doing sleeping. I told him I was not sleeping but only taking the same break that everybody takes except I wasn't drinking coffee on it. He walked away, apparently satisfied with my explanation.

Approximately three days after this, I was told to report to Colonel Hand. Colonel Hand read and then handed me a paper charging me with dereliction of duty; and said that I could take an Article 15 or demand a Summary Court Martial. I refused the Article 15 on the grounds that I was innocent of the charges, and requested a Summary Court Martial. Then I put this in writing on the paper which I returned to Colonel Hand. Shortly after, I returned to work, told the fellows in the shop what happened and asked them if they would testify that I was innocent of the charges of dereliction of duty. Of the men in the shop (approximately 20), 16 of whom I approached signed their names to a letter addressed to Colonel Hand, stating they would testify as to my innocence. I took this letter to the 1st Sgt of the 53d and he turned it over to Colonel Hand. Ever since I was offered a chance to take either Article 15 or the Summary Court Martial, I have never heard a word pertaining to the SCM, either why it was refused me or why it was dropped.

About a week later, I was told to and did report to Colonel Hand. He read me a letter stating that under AFR 39-30, paragraph 17a, my name was being considered for a reduction in grade. The letter also stated that I could present extenuating evidence, or could request a personal hearing before Colonel Hand and that I must acknowledge receipt of this letter. I acknowledged receipt of the letter and at the same time requested in writing that I be given a personal hearing. This acknowledgment and request, I handed to the 1st Sgt of the 53d.

At 0800 on 23 June 1952, the 1st Sgt told me to go to the barracks and bring him all the papers I had on my case, including the reply that I wanted a personal hearing. I had had a copy of all the papers on the case, including the three sworn statements made against me (by Captain Chambers, CMO Hart, and W Sgt Kilpatrick). As ordered, I brought everything to the 1st Sgt and he told me that the hearing had been set for 1300 that day before Colonel Hand. Present

at the hearing was Colonel Hand and 1st Sgt of the 53d. Colonel Hand heard my side of the case as I have stated it in this complaint. He then asked me if I wanted him to interview all my witnesses or if I wanted to let it go. I answered I would like my witnesses interviewed as they could testify as to my innocence. Colonel Hand then told me to wait outside in the 1st Sgt's office. All my witnesses (with the exception of the A/3c and B/1) were called and interviewed by Colonel Hand in his office while I waited outside and heard nothing of the questions asked or the testimony given. About three hours later, Colonel Hand called me into his office where I was alone with him and the 1st Sgt. The Colonel read me an AFR, the number of which I did not understand clearly, but in general it stated that I was incompetent to hold my grade and I was being reduced from A/2c to A/3c. Colonel Hand told me that I must sign this paper. He went on to say that the reason I was getting busted all boiled down to my attitude. I asked Colonel Hand for the copies of the three sworn statements made against me and the copies of the letters that I had received from him and had signed receipts for, and a copy of the paper showing the names of the men who had signed they would testify for me. Colonel Hand told me everything was going on file and I could not have any of my papers returned to me except a copy of the list of the names of the men who had signed to testify for me. Colonel Hand then gave me a letter to sign. I saluted the Colonel, walked out of his office with the unsigned, unread letter in my hand. The 1st Sgt followed me out of the Colonel's office and told me to come to his office. He took the letter from my hand as I reached his office and put it on his desk, handed me a fountain-pen and told me, "We need your signature right here." I protested that I did not wish to sign the letter until I had read it over thoroughly and showed it to the Legal Officer as I believed I was entitled to do. The 1st Sgt said, "The letter states that it must be signed immediately." I said, "Well, if this is an order, I'll have to sign it." The 1st Sgt replied, "That's an order." I signed the letter and asked for a copy. The 1st Sgt refused to give me one. Then I said, "I want a transfer." He said, "You can't have a transfer." Then I quoted AFR 39-30, paragraph 33, to the 1st Sgt. He listened but didn't seem to be paying any attention to me. Then I told him I was going to the I.G. to make a complaint. Then he told me to wait and he went and spoke to Captain Murphy, then came back and told me I had an appointment to see Captain Murphy at 1500, 24 June, concerning a transfer.

I then requested from the 1st Sgt that the copies of the letters I had previously received and returned to him that morning when ordered to do so, be returned to me as they were my personal property, and I believed an injustice had been done to me and I wished to write to my Congressman concerning my case. The 1st Sgt flatly refused to return my copies to me and told me that was all.

On 24 June 1952 at 1100, after being at the I.G.'s office to make this complaint, the I.G.'s office had requested me to get the list of names of the men who signed to testify in my behalf, I went to the Asst 1st Sgt for the list and 1st Sgt Thomas typed the list while I waited and gave it to me. While waiting, I was told don't both reporting to Captain Murphy, my transfer had already been arranged for. I said, "What about those copies of the letters on actions taken?" Sgt Thomas said, "they are being typed up." As yet, I have not received the copies.


