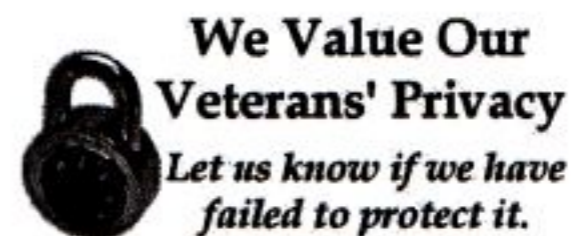
- Death certificate

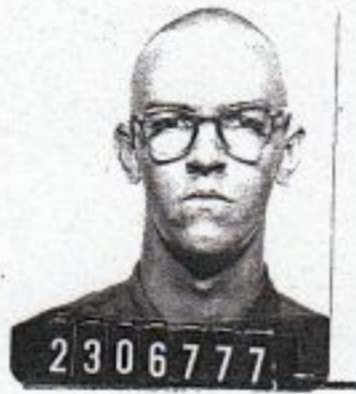
