
A Note on the Bilingual Documents


Thang thinks the translations were done by Nam, a young man 25-28 years old from Phu My district, Bien Hoa, Binh Dinh province. When Nam found the [grave site location] study too complicated, he stopped participating. The notes in the purple boxes of the sketch are by NVA veteran Dang Ha Thuy.


Additionally, Bob March states a number of LZ Bird maps translated by the Vietnamese are in circulation. He does not think Thuy translated them but that Nam, Thang's acquaintance, might have. The multi-page document was taken from the book "Boy Sergeant: A Young Soldier s Story of Vietnam," by Doug Warden, who translated some of the annotations into English. The map was done by an artillery officer. The sketches are not to scale.








Hình 1. Bản đồ này có tỷ lệ xích (50 mét) Figure 1. This map has scale (50 meters)


Although there are still errors that cannot be eliminated, this is the best result we have so far.



Step 3. Based on the above results, I redraw the perimeter of LZ Bird, positions of 150mm and 105mm howitzers, positions of defensive emplacements, positions of Pol Pad, Ditch and other landmarks.

Có thể thấy chúng phù hợp với nhau. Các dấu vết thay đổi bề mặt ở hướng đông bắc và hướng đông của LZ Bird có thể giải thích là do các vụ nổ của đạn pháo binh bắn vào các hướng tấn công chính của đối phương. Thao tài liệu báo cáo sau trận đánh có hơn 1.000 quả đạn pháo đã được sử dụng.


It can be seen that they are compatible with each other. The surface changes in the northeast and east of the LZ Bird can be explained by the explosions of artillery shells fired at the main enemy attack directions. Post-battle documents reported that more than 1,000 shells were used.

Các đối tượng nhỏ bên trong LZ Bird có những sai lệch nhất định vì dữ liệu đầu vào của chúng ta là các sơ đồ được vẽ tay, chỉ mang tính ước lệ. Nhưng chúng ta vẫn có thể thấy cụm lựu pháo 155mm (màu cam) ở phía bắc - đông bắc và cụm lựu pháo 105mm (màu vàng) ở phía nam - tây nam cách biệt nhau như hai bậc thềm.

The small objects inside the LZ Bird have certain deviations because our input data are hand drawn diagrams, which are approximate only. But we can still see the cluster of 155mm howitzers (orange) in the north - northeast and 105 mm howitzers (yellow) in the south - southwest separated like two steps.

The northeastern limit is probably correct, since the outside is a natural slope.


Dựa vào kết quả qua sơ đồ này, chúng ta có thể sơ bộ có các kết luận như sau: 1. Chúng ta có thể thấy vị trí đã phát hiện hài cốt các liệt sĩ ở rất gần phía tây của bãi đáp trực thăng. Như vậy, đây là ngôi mộ nhỏ, được chôn thủ công như các nhân chứng đã mô tả. 2 Còn ngôi mộ lớn vẫn chưa được phát hiện.

Based on the results through this diagram, we can roughly draw the following conclusions: 1. We can see the location where the remains of the martyrs were discovered very near the west side of the helipad (POL PAD). As such, this is a small mass grave, hand-buried as described by eyewitnesses.

2 The large mass grave remains undiscovered.


Step 5. Next, we looked for any surface anomalies in the April 7, 1967 satellite image west of the LZ Bird diagram, localized it, and named them.

Step 6. Next we transfer these marked locations onto modern Google Earth satellite images. It will then be transferred to the search team for exploration and excavation.

Phụ lục – Appendix

Ở tọa độ 14.296053° - 108.887137° (cách tâm của LZ Bird khoảng 125m về hướng Tây Bắc), chúng tôi đã dùng flycam chụp ảnh panorama 360° toàn bộ khu vực. Dựa vào hình dáng núi đồi xung quanh, chúng tối đã xác định được hướng của các hình ảnh tư liệu đã được chụp. At coordinates 14.296053° - 108.887137° (about 125m from the center of LZ Bird to the northwest), we used a drone to take 360° panorama photos of the entire area. Based on the shape of the surrounding mountains and hills, we were able to determine the orientation of the documentary images that were taken.

12 CAV VETERANS ASSIST NVA VETERANS, LZ BIRD: September 2017 we initiated audio-video recordings for a 12 Cavalry Vietnam Documentary. From some of the interviews, Bob March of D Co, 1-12, 1965-66, pieced together a film clip of Delta Troopers in the 1965-66 time period. He posted the film to YouTube; it caught the attention of Vietnamese veterans and a historian named Alexia from Binh Dinh Province. Alexia had coordinated Veterans in the



Imagine the adrenaline rush when Bob contacted me about these communications. Alexia and MAJ Thuy had planned with Linh Hoang Le (Linku), reporter/producer with VTV4 (Vietnam TV) in Hanoi to film the search process. Comar Johnson, Ivory Whitaker, Spencer Matteson, Thomas Crabtree, Doug Warden were all contacted by Bob to schedule a Zoom link up with Linh. On March 9, 12, 21, and 22 we connected with Linh and the search detail on LZ Bird. The search detail was comprised of local villagers, active-duty Vietnamese soldiers, and Linh's production crew. On each of these days we communicated with the people

three and one-half hours each day. Jiggling our memories, we offered our views of where the burial site was, interacting with the

detail supervisor, active-duty MAJ Phan Than Tan. Some remains were gathered along with shoes, packs, and assorted other materials. A memorial to the fallen NVA troops was constructed and a ceremony planned. We were invited to attend the ceremony but unable to due to time constraints. During the link up sessions, Linh did brief interviews with those of us linked in to use in a future documentary. His vision-to produce a documentary about LZ Bird from both the 22d NVA soldiers' perspectives and C Co, 1-12 Troopers, who were in this battle. Steve Hassert of C Co, 1-5 joined us briefly on March 22. After the major thrust of the fight, Troops from C 1-5 and 1-9 came onto the LZ as support and to help gather the bodies for burial as well as evacuating our own casualties. A dozer was brought in by crane chopper and the decision as to where to dig for burial was made by Comar Johnson, C Co,1-12, 3d Platoon Sergeant.

This project has been the buzz throughout Vietnam since January. When we first got together my immediate thought was, I should be there, knowing that we could be of greater help in person. It is not yet complete, and another ceremony is planned for the whole Province of Binh Dinh, which we have been invited to attend if possible.

Much has been written about LZ Bird by many who were not even close and some written by those of us who were there. LZ Bird will be a controversial story among military historians a hundred years from now, just as it has been amongst those of us who were there, for the past 55 years. Should Linh's documentary come about, it will be a resolution to one of the most misunderstood battles of the Vietnam War. It behooves those of us who remain (which are few) from that battle, to do everything possible to contribute our stories along with the enemy we faced. For 55 years, I have always thought it would be an interesting and enlightening experience to sit down with those we faced in battle with a few 'Bau Moi Baus' and compare our views from then and now. I think we would discover we have more in common with our former, tough, and capable enemy soldiers, than we do with most of our 'baby boomer' acquaintances and former school mates.

For those who are not familiar with the Battle of LZ Bird, it was a short lived but significant fight with a well-trained and competent enemy-9th, 8th, and 7th Battalions of the 22D NVA Regiment. At 0105 hrs, 27 December 1966, they overran LZ Bird. Charlie Co, 1-12 had been dispatched to perimeter duty at Bird after the Battle at 506 Valley, 16-17 December 1966. In 506 Valley major casualties accrued to Charlie and Delta Company. Delta Company remnants had been placed on Pony after 506. With 112, B Co, 2-19th Artillerymen at Bird and 84 C Co, 1-12 Troopers, we outnumbered by 750 PAVN Soldiers. After the battle, with dispatched patrols brought in, C Co had only 24 men remaining. 29 KIAs and WIA ratio of 5 to 1 was the toll for this 'Stand at Bird.' Numerous medals for Valor were awarded to American Troops for their stand. The first Medal of Honor to a 1-12 Cavalry Trooper was awarded to SSG Delbert O. Jennings. Earlier, I mentioned the adrenaline rush that came when Bob March first contacted me, and it has been surging during this write up. I think of the possibilities in Linh's proposed documentary and how it plays into our own project we started in September 2017. I encourage ALL to view the news clips Linh has produced for this link up. They can be accessed on Delta Company 1-12 web site at <www.cattrack6india.com>. You can read Bob March's outstanding article about LZ Bird and our link up with Linh and crew in Boot to Boot, Delta Company Newsletter on the site. Look for more about the progress of this project and the LZ Bird story in July/ August, September/October, and November/December issues. See you all in Dayton, OH in July and Branson, MO in September. Until then- "Soar with the Chief Chopper Pilot, Walk Lightly with the Head Point Man, Roll with the Lead Tanker!"

am looking for information about the mass grave of my comrades buried by U.S. Military. When our unit ambushed the Xuan Son-LZ artillery base at dawn on December 26, 1966, many comrades were sacrificed. I am older and have been looking for this job for many years. All information is valuable.

This has spiritual significance for Vietnamese people, 1-12 battalion defended this base and directly participated in the battle. I apologize if this bothers you. Our veterans look forward to helping American Veterans. Regards!"
