

1. **ASSIGNMENT.**—Local duty assignment orders; local routine additional duty assignment orders; orders for enlisted personnel to travel as guard or attendant; travel orders in connection with reenlistment; TDY orders.
2. **PERSONAL AFFAIRS.**—Correspondence and other documents relating to such matters as: telephone in quarters; operation of automobile on post; credit at Army exchange; ration coupons; requirements or opportunities for commission; attendance at officer candidate school or other schools; reports of lost passes; request for execution of forms; personal affairs interview sheets; personal data cards; extra copies of oaths of office; nonpayment of personal debts; VA Form 9-357 (*Claim for Disability Insurance Benefits*); and other matters of a similar nature.
3. **DISCIPLINE.**—Officers acquittal courts-martial orders; Charge Sheets (*DD Form 458*) with related correspondence; complaints and accusations that do not warrant investigation; minor infractions of military discipline; copies of nonpunitive administrative admonitions and reprimands administered to officer and enlisted personnel as corrective action.
4. **MISCELLANEOUS.**—Communications pertaining to transmission and receipt of records and exchange of information to complete or correct records (*after records have been completed or corrected*); reports of arrival and departure of officers; informal office memorandums; clearance sheets; worksheets; checklists; transmittal slips and inter/intra office memos; cross-reference sheets which refer to papers of temporary usefulness; and papers of a similar nature.
